INFORMATION FOR AUTHORS AND THEIR EMPLOYERS

IMP policy. In connection with its publishing activities, it is the formal policy of IMP to own the copyrights to all copyrightable material in its technical publications and to the individual contributions contained therein, in order to protect the interests of the IMP, its authors and their employers, and, at the same time, to facilitate the appropriate re-use of this material by others. IMP distributes its technical publications throughout the world and does so by various means such as hard copy, microfiche, microfilm, as well as electronic and online-media. It also abstracts and may translate its publications, and articles contained therein, for inclusion in various compendiums and similar publications, etc. When an article is submitted to IMP for publication, IMP understands that its acceptance of the article implies that IMP has the rights to do all of the things it normally does with such an article.

IMP Policy - CLEARANCE OF PAPERS - applies to all material submitted to IMP: "IMP must of necessity assume that material presented at its meetings or submitted to its publications is properly available for general dissemination to the audiences these activities are organized to serve. It is the responsibility of the authors, not IMP, to determine whether disclosure of their material requires the prior consent of other parties and, if so, to obtain it." Furthermore, if an author uses within his/her article previously published and/or copyrighted material, IMP must assume that permission has been obtained for such use and that any required credit lines, copyright notices, etc. are duly noted.

IMP obligations. In exercising its rights under copyright, IMP will make all reasonable efforts to act in the interests of the authors and employers as well as in its own interest. As a convenience and courtesy to the technical community, IMP routinely grants permission upon request to authors to use in their manuscripts graphs, tables, figures, or other portions of works by other authors for which copyright has been transferred to IMP. IMP reserves the right to use any parts or the entire manuscript in revised editions, derivative works, etc. published by IMP. In handling third party reprint/republication requests for a IMP work, IMP requires that 1) the consent of the first-named author besought as a condition in granting republication (of a full paper) to others. 2) The consent of the employer be obtained as a condition in granting permission to others to re-use all or portions of a paper for promotion or marketing purposes.
